Memorandum of Understanding (MoU)

Between

Chettinad Academy of Research and Education (CARE)

And

Chettinad Dental College & Research Institute (CDCRI)

This MOU is executed on 9th December, 2017 at Kelambakkam by and between **Chettinad Academy of Research & Education (CARE)** (a Deemed to be University under Sec.3 of the UGC Act,1956) at Chettinad Health City Campus, Rajiv Gandhi Salai (OMR), Padur, Kelambakkam - 603 103, Kancheepuram District, Tamil Nadu, hereinafter referred to as "CARE" (which expression shall unless repugnant to the context or meaning thereof be deemed to mean and include its successors and assigns of "CARE") represented by its Registrar and **Chettinad Dental College & Research Institute (CDCRI)**, sponsored by Rajah Muthiah Chettiar Charitable & Educational Trust and permitted by Dental Council of India, at Chettinad Health City Campus, Rajiv Gandhi Salai (OMR), Padur, Kelambakkam 603 103, Kancheepuram District, Tamil Nadu, hereinafter referred to as "CDCRI" (which expression shall unless repugnant to the context or meaning thereof be deemed to mean and include its successors and assigns of "CDCRI") represented by its Principal

Whereas **CDCRI**, an outstanding Dental Institute affiliated to The Tamil Nadu Dr. M.G.R. Medical University offers B.D.S and M.D.S Degree courses and renders health care services and whereas **CARE** offers inter-disciplinary and multi-disciplinary innovative programmes in the broad fields of Life Sciences and related technologies and having state of-the-art instructional and infrastructural facilities, renders health care services of international standard and promotes various research and development activities leading to number of publications and patents.

Whereas both the Institutions are functioning in the above mentioned same Campus and in accordance with mutual desire to promote learning, research and development, agree to have an Memorandum of Understanding (MoU) as follows:

CARE and CDCRI are individually referred to as 'Institute" and collectively as "Institutes".

(1) Broad Objectives

This MoU is signed between the Institutes for the purpose of Academic Collaboration at academic levels that will encompass exchange of students and members of faculty between the two Institutes. In addition, active efforts will be made to develop joint training and research programmes that will be pursued in a collaborative spirit. Some of the collaborative areas may include the following.

- 1. Joint research & development
- 2. Staff Exchange/Deputation
- 3. Facilities sharing platform
- 4. Jointly organizing seminars, workshops, conferences and other academic activities
- 5. Student internship
- 6. Conduct of Community Development Programmes

(2) Joint Research & Development

The Institutes intend to pursue co-operation in research and development supporting the development of technical standards in the fields of medical, dental education and surgery.

The Institutes will meet regularly and as needed to discuss possible subjects for future cooperation, to review the state of current cooperative projects and the implementation of the joint cooperation on priority subjects.

The Institutes intend to enter into project-specific agreements for cooperative scientific and technical activities conducted pursuant to this MoU. Such agreements shall include detailed provisions for the conduct of research and other terms as

(3) Staff Exchange / Deputation

Both Institutes agree to explore opportunities for staff exchange between each Institution. It includes exchange of technical information, reference data, exchange of visits etc.

Both Institutes shall encourage teaching in lecture or laboratory environments, curriculum development, sharing of expertise and resources etc., Resource persons from either Institutes shall be paid Honoraria by the Host Institute for lectures delivered at mutually agreed terms.

Both Institutes agree that whenever eminent scientists with specialization in the areas of co-operation visits at either Institutes will be encouraged to visit the other Institutes.

Host Institution shall not have any financial obligation to either the visiting academic staff or the Home Institute. If the visiting academic staff member falls sick/meets with accident, the Institutes agree that the Host Institute will not be held responsible for any costs incurred. All costs associated with travel arrangements, accommodation and associated expenses shall be the responsibility of the participating academic staff/faculty/Research Scholar.

Both Institutes agree that the visiting academic staff shall retain his employee status within the Home Institution and will not generally be considered as an employee of the Host Institution. However, the visiting staff is expected to abide by the same rules as those for all the staff of the Host Institution and applicable rules from the Home Institution.

(4) Facilities Sharing Platform

The two Institutes agree to share their respective important R&D facilities in order to promote academic and research interaction on a mutually agreed terms for the purpose of this MoU. Research Scholars of both the Institutes are welcome to make use of the library resources/ Laboratories of each other and to have academic interaction with the Faculties.

Research Scholars and Teaching Faculty of both the Institutes will explore possibility of taking up collaborative research work and also apply for funding from national and international agencies, governments and other funding agencies with the approval of the respective Heads of Institutions.

Chettinad Hospital and Research Institute, a constitute college of CARE shall share its faculty resources in the departments of Anatomy, Physiology, Biochemistry, General Medicine, Pathology, Microbiology, Pharmacology and General Surgery and also its laboratories for the purpose of academics and patient management in CDCRI.

(5) Jointly organizing Seminars, Workshops, Conferences

Both the Institutes agree to hold/conduct whenever feasible, joint sponsored conferences, seminars, workshops, training programmes etc., Participating members shall be treated to be on duty with the parent Institution for the period of such programmes.

The Host Institute shall provide accommodation to the participating members from the visiting Institute wherever feasible and necessary.

(6) Students Internship

Students from one Institute may visit the other and complete an Internship for a period of 3 to 6 months which may be assessed as per their project/course requirement at Home Institute

(7) Conduct of Community Development Programme

Programmes for community development under the aegis of both the Institute such as health assistant training etc., shall be conducted. Usage of facilities shall be mutually worked out.

(8) Mode of Operation

One member from the CARE and one from the CDCRI will be designated as the Single Point of Contact (SPOC) for the coordination role for all programmes organized. The SPOCs shall be responsible for the preparation of the annual plan for approval of the Co-ordination Committee and the SPOC shall implement approved plan and promote cordial interaction between the Institutes.

(9) Budgetary Provision

There may be budgetary provision in both the Institutes to meet the travel and contingency expenses in connection with the MoU. The Budget may be administrated by the respective Heads of Institutes.

(10) Intellectual Property and Confidentiality

In respect of each project and programme of co-operation, the Institutes shall negotiate and mutually agree in writing on their respective rights to intellectual property and commercial exploitation of the same (including without limitation, trademarks and service marks, copyrights, patents, designs and confidential information pertaining thereto).

Neither Institute shall, at any time disclose to any third party any confidential information of the other Institute which is acquired in the course of activities under this Memorandum, a collaborative project or programme, without the prior consent

of the other Institute in writing.

(11) Co-ordination Committee

There shall be one Co-ordination Committee for coordination and monitoring the collaborative programmes between the Institutes consisting of Senior Professors (one each) from both the Institutes.

The Co-ordination Committee shall review the progress made in the previous academic year, approve the annual plan for cooperation activity from the following year, consider the addition/deletion of areas of co-operation between the Institutes and consider the continuance of the MoU.

(12) Amendment and Termination

This MoU shall be valid for a period of five years (5) from the date of its signing. During the period of its validity, the MoU can be amended at any time by mutual consent of both the Institutes. This MoU can be terminated by either of the Institutes by giving advance notice of six (6) months and without jeopardizing the coursework or research of any of the students of either Institute.

(13) Arbitration / Jurisdiction

Any dispute or differences arising out of interpretations of the clauses listed above shall be resolved by mutual consultation and if the mutual consultation fails, shall be settled as per the provisions of the Indian Arbitration and Conciliation Act, 1996 and the Award of the Arbitration shall be final and binding on the parties to the MoU. In general, Courts in Chennai shall have the jurisdiction.

The MoU is made out in 2 (two) original copies one for each of the parties. All original copies here of are identical and legally equal.

PREFACE

TO

BDS COURSE REGULATIONS 2007

(Modified: 25.07.2007)

Framed by the Dental Council of India and approved by the Central Government under the Dentists Act, 1948 – vide Government of India, Ministry of Health & Family Welfare (Deptt. of Health's) letter No.V.12012/3/2006-DE dated 25.07.2007.

I. Dental subjects:

- (a) Pre-clinical Prosthodontics and dental material lab 3000 sq.ft.
- (b) Pre-clinical conservative lab 2500 sq.ft.
- (c) Oral biology and oral pathology lab 2500 sq.ft.
- (d) Laboratory for orthodontics and pedodontics 1500 sq.ft.
- II. **Medical subjects:** (only for independent dental colleges):7500 sq.ft.
- (a) Anatomy dissection hall with storage for cadavers, osteology, demonstration room etc. Area 2500 sq.ft.

The following have been added in terms of (1st Amendment) notification published on 7th January,2008 in the Gazette of India.

- (b) One laboratory for physiology and pathology and microbiology with stores and preparation rooms for individual subjects attached to it. Area 2500 sq.ft. for each subject
- (c) Laboratory for biochemistry and pharmacology with store and preparation rooms separately for both subjects -2500 sq.ft. for each subject

III. Clinical:

(a) Prosthodontics - Plaster room

Polymers room Wax room Casting laboratory

Ceramic lab 2500 sq.ft.

(b) Conservative Dentistry – Plaster room

Casting & ceramic laboratories ... 600 sq.ft.

- (c) Oral pathology for histopathology ... 600 sq.ft.
- (d) Haematology and clinical biochemistry: a laboratory for routine blood and biochemical investigation and urine analysis ... 300 sq.ft.

18. **Distilled Water Plant**

The following have been added after the Serial No. 18. Distilled Water Plant, in terms of (1st Amendment) notification published on 7th January,2008 in the Gazette of India.

"Note: Minimum built up are of the dental college building other than Hostels and Staff Quarters should not be less then 60.000 sq. ft. in 1^{st} Year and 1,00,000 sq. ft. in 3^{rd} Year as per DCI Regulations, 2006."

TEACHING AIDS:

Audiovisual – Adequate number of overhead projectors, slide projectors shall be provided in the lecture halls and seminar rooms attached to various departments. It is also desirable to have an LCD or DLP projector for multimedia presentations.

Computers – The administrative area, clinics, stores and library shall be provided with computers & printers preferably interconnected for better co-ordination.

General Hospital:

The applicant owns and manages a General Hospital of not less than 100 beds as per DCI (Establishment of New Dental Colleges, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity in Dental Colleges) Regulations, 2006 with necessary infrastructure facilities including teaching pre-clinical, para-clinical and allied medical sciences in the campus of the proposed dental college,

or

The proposed dental college is located in the proximity of a Government Medical College or a Medical College recognised by the Medical Council of India and an undertaking of the said Medical College to the effect that it would facilitate training to the students of the proposed dental college in the subjects of Medicine, Surgery and Allied Medical Sciences has been obtained,

or

Where no Medical College is available in the proximity of the proposed dental college, the proposed dental college gets itself tied up at least for 5 years with a Government General Hospital having a provision of at least 100 beds and located within a radius of 10 K.M. of the proposed dental college and the tie-up is extendable till it has its own 100 bedded hospital in the same premises. In such cases, the applicant shall produce evidence that necessary infrastructure facilities including teaching pre-clinical, para-clinical and allied medical sciences are owned by the proposed dental college itself.
