### **Guidelines for Allotment of MDS seats for admission session 2020-21 in Chettinad Dental College & Research Institute.**

Chettinad Dental College & Research Institute is a self financing institution affiliated to The Tamil Nadu Dr. M.G.R Medical University. There are **two categories of seat allotment** namely government self financing quota and management quota.

All seats in Chettinad Dental College & Research Institute are allotted by the **Selection Committee, Directorate of Medical Education, Kilpauk, Chennai, Tamil Nadu only and Not through DGHS, New Delhi.**

So the NEET qualified students are to apply online separately for government self financing quota and management quota counseling through the Selection Committee, Directorate of Medical Education, Chennai, Tamilnadu in the following website only

### **I. Important information for Government self financing Quota:**

Candidates seeking for admission to MDS Course 2020-21 session under government self financing quota in Chettinad Dental College & Research Institute, affiliated to The Tamilnadu Dr.M.G.R Medical University in Tamil Nadu, The online submission of Application form can be accessed at the following official websites: [www.tnmedicalselection.org](http://www.tnmedicalselection.org) / <https://tnhealth.tn.gov.in/>

In addition to the filled-in online application form, Candidates should also send the Print out of filled in online application form (Hard copy) with necessary enclosures. The cost of application fee is Rs.3000/- (Non-refundable) and should be paid online via bank payment portal in the

websites. A copy of receipt of payment paid by the candidates should be attached along with their application form. (as per the 2019-20 admission criteria)

### **Eligibility Criteria for Government self financing Quota**

(a) Candidates should be a Citizen of India and should have completed BDS course including the entire CRRI period in the State of Tamil Nadu. (Candidates who complete CRRI in other States are not eligible).

(b) Candidates of Tamil Nadu Nativity who have completed BDS in other States should furnish a Certificate of Nativity in Tamil Nadu issued by the competent authority only.

### **Eligibility Criteria for Management Quota**

The NEET qualified Candidates should be a Citizen of India and should have **completed BDS course in any institution in India**, approved by Dental Council of India or NRI's as per the prospectors of Selection Committee, Directorate of Medical Education, Chennai, Tamil Nadu guidelines.
